Events & Format: Men's and Women's singles and doubles and Mixed doubles in an Open division in accordance with USA Badminton and IBF rules. *** **IBF Rally system scoring will be used.** *** See website for scoring details.

Entry Deadline: Open Division - April 7th, 2006

Registration: Registration will be at Don Shula's Athletic Club, and begins Wednesday April 26, 2006, 7:30 PM, and on Thursday, April 27th, 2006, 8:00 AM.

Eligibility: Participation in the VIII Southern/PanAm International is open to members of any national association recognized by the IBF and any currently registered members of the USAB. National associations should list their players according to national ranking on the entry form. USA Badminton memberships will be available at the tournament. **Each event is limited to 32 individuals/teams.**
